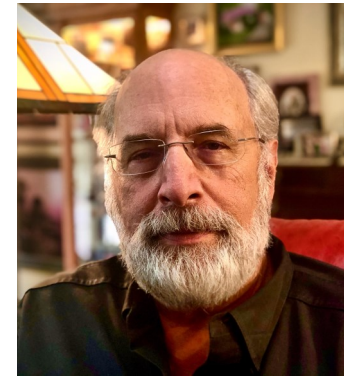
Best Practices for Dude Ranch Fire Mitigation Strategies

Carroll prepares wildfire mitigation and prevention plans for clients across the West and is an expert consultant on wildfire prevention and mitigation.



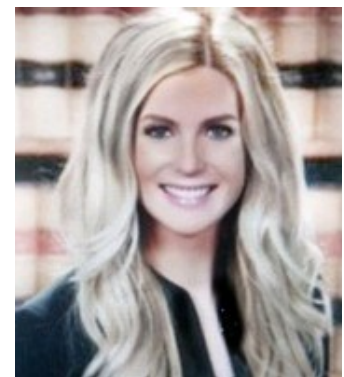
